- The Award is open to all Singaporean / Permanent Resident young executives in the retail industry in Singapore, who are aged 30 or below as at 30 April 2018, and are working in retail companies that are Ordinary Members of the Singapore Retailers Association.
- He / she must be supervising / managing at least three subordinates.
- The application can be for any eligible young executive from any department within the Company.
